How Do I Register?

Are There Any Discounts Available?

Tri-State offers 3 ways to increase the affordability of our box leagues. "Play More | Save More" offers a 10% discount for individuals registering for 2 sessions and a 15% discount for registering for all 3 sessions. There is a sibling discount of 10% when 2 or more siblings are registering for the same session (cannot be combined with "Play More | Save More"). And there is a discounted team rate available for groups that would like to enter as a complete team. Where Can I Find The Schedule And Rosters?

Three (3) days prior to the start date of the session, ALL schedules and rosters will be posted online at www.trilax.com. Schedules are week-by-week for the first 2-weeks and then a full schedule will be posted.

What is the game format?

Players should be prepared to play one (1) 45-minute game each week. The game clock does start as soon as the previous game ends. Players should be ready to step on the field right away to ensure maximum playing time. All games are 7 v 7, 6 field players and a goalie. Players are required to wear the same equipment that would be required during their outdoor season.
