TRI-STATE LACROSSE TOURNAMENT TERMS & CONDITIONS

REGISTRATION To officially register for a Tri-State Lacrosse sponsored tournament, teams must submit a completed application along with the specified monetary deposit for the event. Team application and deposit serve to secure a team's entry until the final payment deadline. Full payment is due 15 days prior to the start of play.

PAYMENT Deposits are non-refundable and are due at the time of registration. Tournament fees must be paid in full at least 15 days prior to the start of play. Tournament fees can be paid via check, money order or credit card. Credit card payments must include a 2% processing fee. Returned checks require payment by cashiers check or money order and include a \$50 returned check fee.

TOURNAMENT WAIVERS Every player participating in a Tri-State Lacrosse sponsored tournament is required to fill out and provide a parent signed waiver. Tournament waivers are available in two (2) formats, a "Team Waiver" or an "Individual Player Waiver". Either format is acceptable and both require basic player information and a parent/guardian signature. These waivers are due prior to the start of play.

REFUNDS All deposits are non-refundable. Teams who have registered and paid in full, may request a refund, less their deposit, up to thirty (30) days prior to

the start of play. Within thirty (30) days of the start of play, there are NO REFUNDS for any reason. Should Tri-State Lacrosse cancel an event for any reason prior to the start of play, teams will receive a complete refund. Should an "act of God" prevent 2/3 or more of play, a credit will be available to effected teams.

RULES OF PLAY A complete set of tournament rules will be provided online at www.trilax.com for each event. Rules will designate the number of and length of games each team will play. Upon registration, teams confirm that they have reviewed and agree to the rules set forth for the specific Tri-State Lacrosse sponsored tournament.

CODE OF ETHICS AND SPORTSMANSHIP All Tri-State Lacrosse sponsored tournaments operate at the highest level of sportsmanship. A Code of Ethics and Sportsmanship is available at www.trilax.com. Tri-State Lacrosse requires that all team coaches and administrators have read the Code of Ethics and Sportsmanship. Additionally, they agree to make their players and parents aware of the Code of Ethics and Sportsmanship and follow the behavioral guidelines set forth by it. Failure to act accordingly will lead to expulsion from the tournament, without a refund, and may be prohibited from participating in any other Tri-State Lacrosse sponsored event for up to two (2) years.

ELIGIBILITY REQUIREMENTS Each Tri-State Lacrosse sponsored tournament specifies eligibility requirements for each division. This can be age driven or grade based. By registering for a division, team coaches and administrators confirm they have read the eligibility requirements and that EVERY player on the team meets these requirements. Players may always "play up" but never down. If it is determined that a team plays in a division/bracket that they do not age/grade qualify for they will be disqualified and will not receive a refund. The program responsible for the infraction will also be subject to a two (2) year ban from participating in any Tri-State Lacrosse sponsored event.

TRAVEL INFORMATION Attending teams will have access to certain travel related benefits including, but not limited to, discounted hotel blocks, van and bus services and restaurant discounts. All offers will be available for teams to review at www.trilax.com. Offers are subject to the terms and conditions of the provider and it is the team's responsibility to be aware of the rules, regulations and/or restrictions set forth by the provider. Participating vendors are updated on specific details of the tournament that may provide teams with added benefits (i.e. field maps, extended continental breakfast, waived wi-fi connection charges, etc.)
